

Terms and Conditions of the competition (the Competition)

The Competition is organised by the Fatima Bint Mubarak Ladies Sports Academy (**Organiser**). By entering the Competition, you accept and agree to abide by all of the following terms, together with any additional rules provided by or on behalf of the Organiser:

Specific Terms

- To participate in the Competition you must: (1) be 18 or over on 25 February 2017 or have parental permission to enter the Competition; (2) provide all information requested by the Organiser, and such information must be true, complete and accurate; (3) not be an employee, intern, contractor or sponsor of the Organiser or Flash Entertainment FZ LLC (or an immediate family member of any of the foregoing)
- By entering the Competition, you have the chance to win a free two-night stay at the Marriott Downtown Abu Dhabi Hotel (the **Prize**)

- If you win, you must acknowledge your selection as winner within 48 hours. If you fail to do so, the Organiser may revoke the Prize and award it to another entrant
- The Prize will be available to collect at the Organiser's head office from Sunday 26 February 2017 from 9 am to 3 pm. You will need to bring photographic identification to collect the Prize.

General Terms

- The Organiser's decision as to the winner is final in all respects and no correspondence will be entered into regarding the outcome of the Competition
- Use of the Prize is subject to the Marriott Downtown Abu Dhabi terms and conditions
- The Prize is a package (such that no element of it may be obtained without receipt of all other elements), is non-transferable, non-refundable and non-redeemable for cash or other goods or services

Bots and Click Farms

- The Organiser is aware of sites, apps and service providers which allow users/ clients to artificially inflate the number of likes (or clicks or favourites, as the case may be) which a social media post attracts. For the purposes of the Competition, such sites, apps and service providers are referred to as **Bots**.

- The Organiser may immediately disqualify any submission to the Competition which appears (in the Organiser's sole discretion) to be supported by Bots or by the use of Bots (whether or not such use is intentional, and regardless of the extent to which Bots comprise the total number of likes, clicks or favourites which a post attracts). No correspondence will be entered into in the event of such disqualification, and any decision to disqualify will be final. The Organiser reserves the right to publicise the use of Bots by any person disqualified from the Competition.

Instagram

- The mechanism by which Flash will determine the winner of the Competition is operated by Instagram (the **Platform**). Flash has no responsibility for failures in the communication or transmission of data between you and the Platform or between the Platform and Flash
